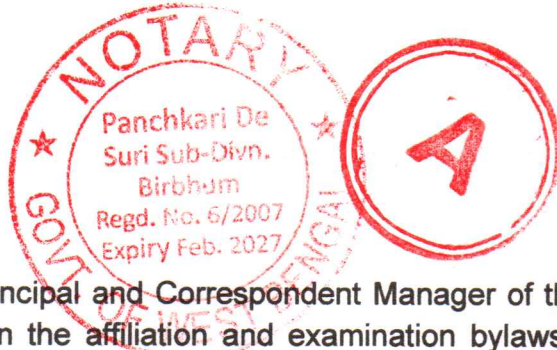
AFFIDAVIT
